WHEREAS on January 25, 1972, an election was held, with the electors voting in favor of formation of a vector control district in a portion of west Umatilla County;

WHEREAS on March 2, 1972, the Umatilla County Court adopted an Order forming the West Umatilla Vector Control District, now known as the West Umatilla Mosquito Control District;

WHEREAS pursuant to ORS 452.080, the county board of commissioners is to appoint the members to the board of trustees for a vector control district;

WHEREAS the term for Positions #1 and #5 have expired, and William L. Caplinger and Glenn S. Chowning are willing to continue to serve, are qualified to be appointed, and are recommended for re-appointment.

NOW THEREFORE, the Board of Commissioners orders that the following are appointed to the West Umatilla Mosquito Control District Board of Trustees, for the stated position and term:

Position #1	William L. Caplinger, beginning May 1, 2018 and ending April 30, 2022
Position #5	Glenn S. Chowning, beginning May 1, 2018 and ending April 30, 2022
