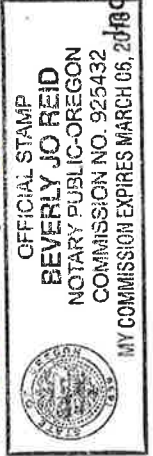

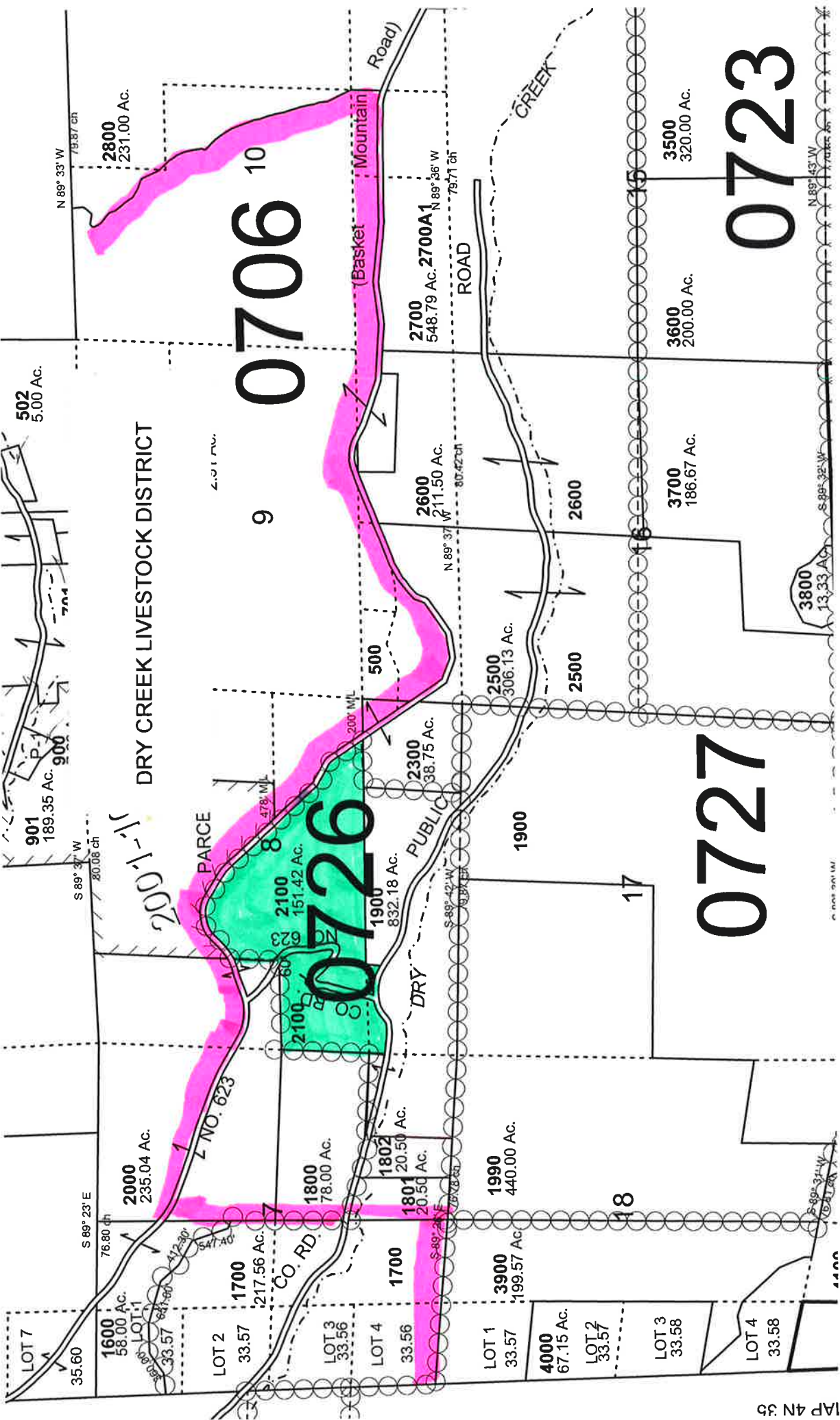

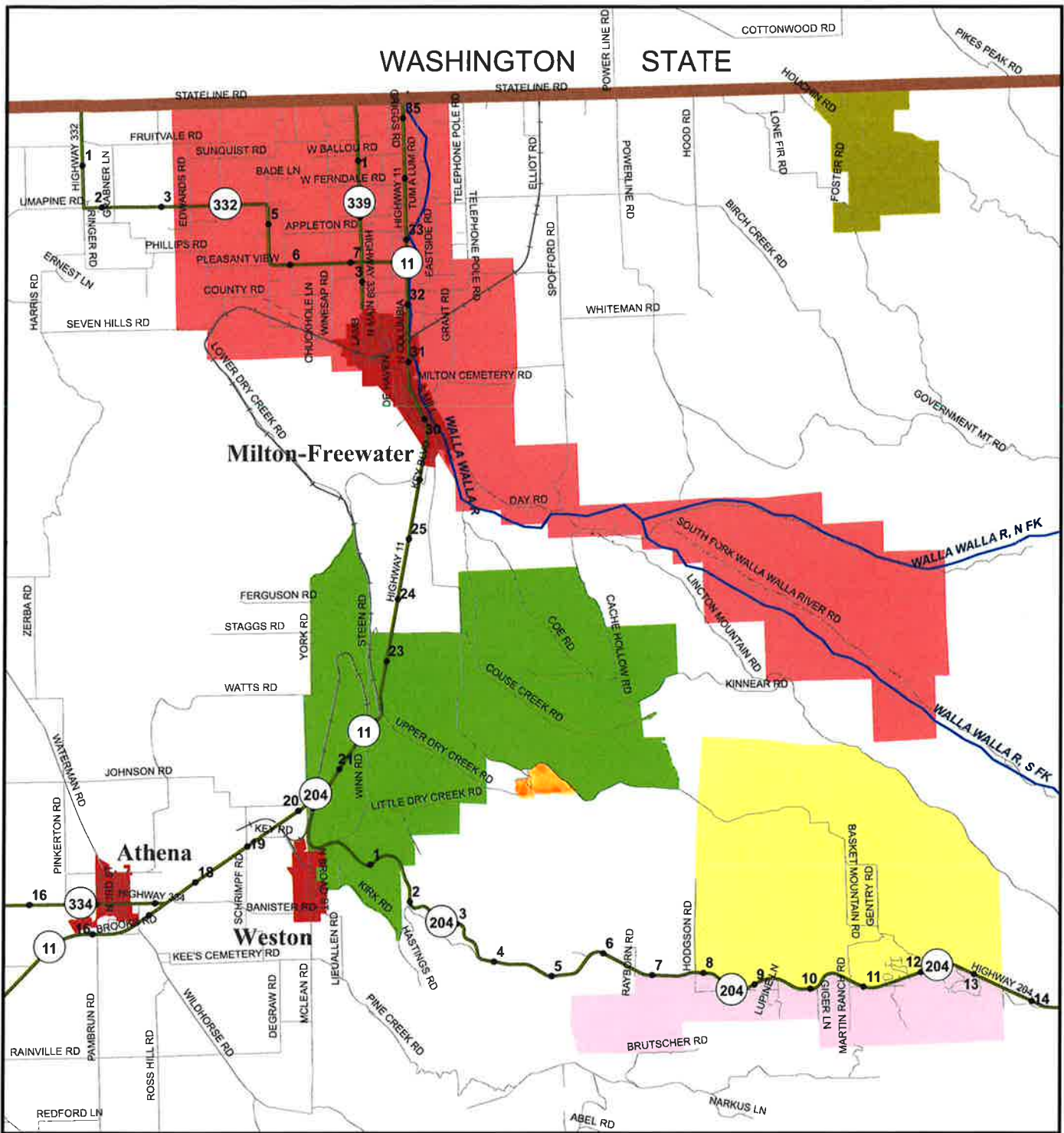

WHEREAS, in accordance with ORS 607.020, the Board of Commissioners received a petition from a property owner that owns property in an unincorporated area of the county, that it desires property to be annexed into the Dry Creek Livestock District; and

WHEREAS, the petition was signed by all the owners of all the lands in the territory to be annexed; and

WHEREAS, notice of the public hearing on this potential annexation was published in the East Oregonian on December 9 and 16, 2017, and included the time and the place of the hearing, described the territory proposed to be annexed, and named the classes of livestock that are not permitted to run at large within the district;

WHEREAS, on January 17, 2018, the Board of Commissioners held a public hearing on the proposed annexation.

NOW THEREFORE, the Board of Commissioners orders that:

1. The requirements of ORS Chapters 607 concerning annexation of territory into the Dry Creek Livestock District have been met.
2. The petition for annexation was signed all owners so that pursuant to ORS 607.020(6) an election of the proposed annexation is not required.
3. In accordance with 607.020(7), effective immediately, the following described property is annexed into the Dry Creek Livestock District:

All that portion of the Southwest Quarter of the Southwest Quarter, lying northerly of the road right of way aka Upper Dry Creek Road; North Half of the Southwest Quarter; Beginning at a point on the West line of the Southeast Quarter of the Northwest Quarter where the South line of the County Road No. 628 aka Basket Mountain

Road crosses said West line; thence South 495 feet, more or less, to the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence Easterly along the centerline of said Section 8, a distance of 1,980 feet, more or less to County Road No. 628; thence Northwesterly along said County Road No. 628 to the point of beginning. All being in Section 8, Township 4 North, Range 36, East of Willamette Meridian, Umatilla County, Oregon.
