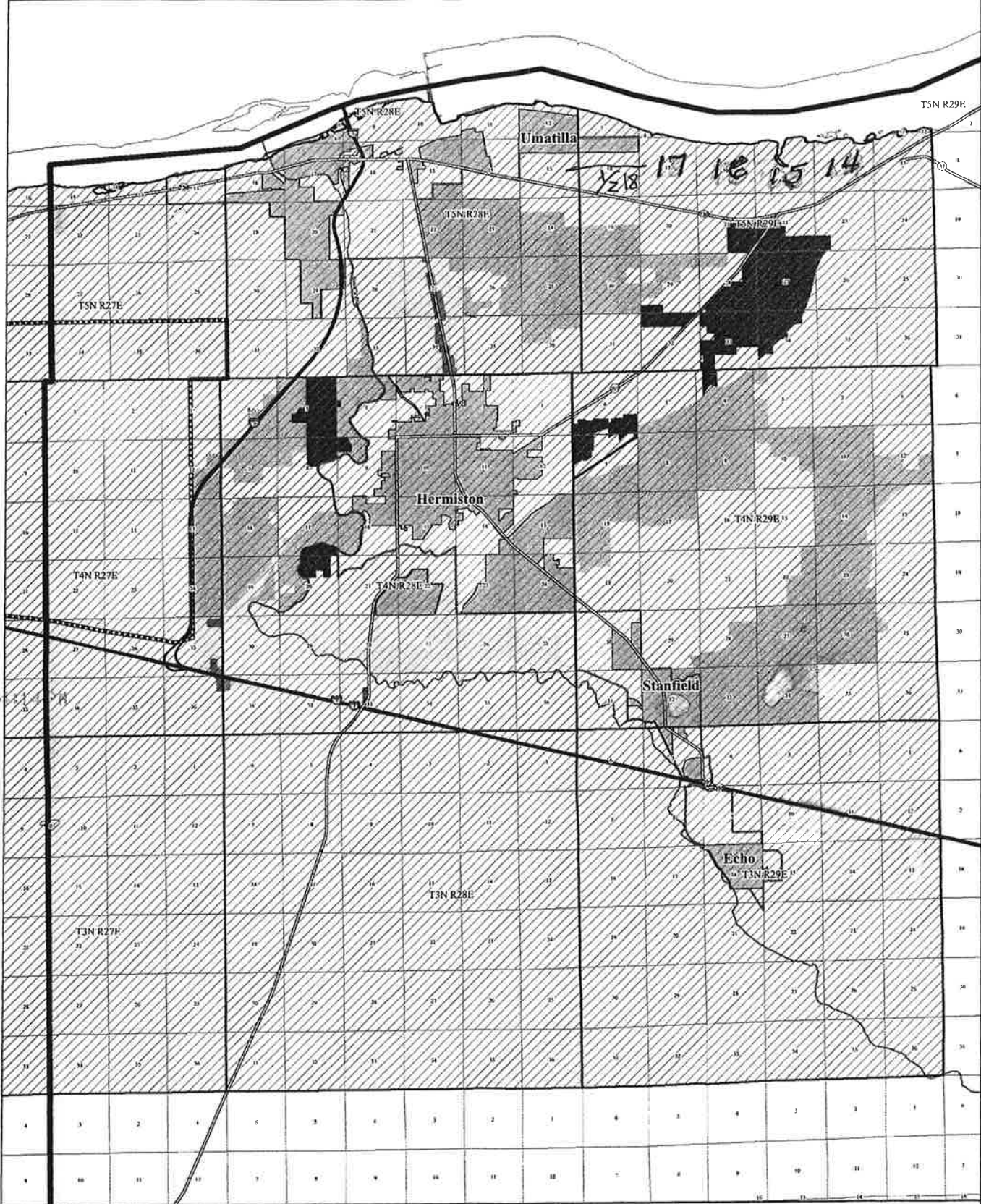

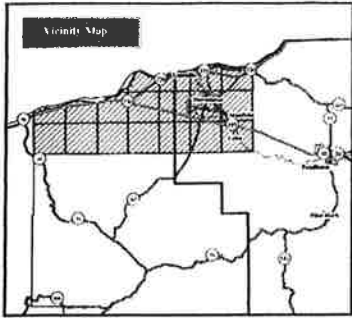

WHEREAS, in accordance with ORS 607.010, the Board of Commissioners has received the attached petition from property owners that own property in an unincorporated area of the county, that they desire to create a livestock district to be known as the Salmon Point Livestock District;

WHEREAS, the petition was signed more than 6 electors within the boundary of the proposed district;

WHEREAS the proposed district contains not less than 2,000 acres;

WHEREAS the classes of livestock not be permitted to run at large within the proposed livestock district are animals of the bovine species, horses, mules, asses, sheep, goats and swine.

NOW THEREFORE, the Board of Commissioners orders that:

1. The proposed boundary for the proposed Salmon Point Livestock District is as follows:

All of Sections 14, 15, 16 and 17, and South Half of Section 18, all being in Township 5 North, Range 29, East of Willamette Meridian, Umatilla County, Oregon.

2. A hearing will be held on February 7, 2018, at 9:00 a.m., in Room 130, Umatilla County Courthouse, for a hearing on the petition for creation of the Salmon Point Livestock District.

3. A notice of the hearing will be published in the East Oregonian, a newspaper of general circulation in Umatilla County.
