WHEREAS the 2011 Legislature passed House Bill 3560, codified as ORS 610.150 to 610.155, for a wolf predation loss compensation program;

WHEREAS on February 9, 2011, the Board of Commissioners adopted Order No. BCC2012-15, establishing a Umatilla County Wolf Depredation Advisory Committee;

WHEREAS with the death of Randall L. Severe, there is a vacancy on the committee; Timothy D. Hawkins is recommended to fill the vacancy and he is willing and eligible to serve.

WHEREAS the terms of some of the committee members have expired, and to allow for the completion of the grant cycle, an extension of the terms is desirable.

NOW THEREFORE the Board of Commissioners orders that:
