Pendleton House – 514 SE 13<sup>th</sup> – four bids submitted \$8,000 to \$41,011

Pendleton House – 44786 Mission Road – two bids submitted of \$37,500 to \$61,000

All highest bid amounts exceed the minimum bid amount and are before the Board for approval
