SUBJECT: Body Armor

<p>We need new and replacement body armor for several deputies, due to on-going new hires and expiration/wear and tear issues of current Deputy's equipment. Body armor is a required piece of critical safety equipment for law enforcement. All body armor has an expiration date per manufacturers, so this is a recurring need. The body armor listed is consistent with our current uniform standard issue. The body armor quote (attached) is equipment for the Criminal, Corrections and Civil Divisions. This year unfortunately there is not a grant for the Federal reimbursement program which we were awarded in previous years.
