WHEREAS the county needs to replace the surveillance cameras for the Umatilla County CDDP/Juvenile building;

WHEREAS under Umatilla County Code of Ordinances Section 36.06(B)4), an alternative to procurement by competitive bids is the purchase of goods or services where there is only one seller or product of the quality available;

WHEREAS the video surveillance system at the building was first installed when the facility was used as a detention facility in the 1990s, and needs to be updated to meet current needs;

WHEREAS Uni-Tech Communications installed the system in use at the courthouse and the other county facilities, and also has conducted any maintenance or installed additions to the current system;

WHEREAS the new proposal would replace the cameras and system at the building and needs to be compatible with the system at other county facilities so that the cameras can all be managed and viewed by the current system;

WHEREAS to be able to install new cameras and related equipment, there is only one provider for the services and equipment;

WHEREAS Uni-Tech Communications has submitted a proposal for the new cameras and installation services in the total amount of \$32,697, a copy of which is attached to this order.

NOW THEREFORE, the Board of Commissioners orders that:

1. Due to the requirements for the cameras and system to be compatible with the existing system, knowledge of existing system, and timeliness, there is only one seller of the quality required available.

2. The procurement of the CDDP/Juvenile building cameras, for related equipment and installation, from Uni-Tech Communications, is exempt from the competitive bidding process under the Umatilla County Code of Ordinances.

3. Umatilla County is authorized to purchase the equipment and services from Uni-Tech Communications for \$32,697.
