

Agreement
City of Umatilla
County of Umatilla
Road Jurisdiction

This agreement is executed this day of November, 2023, between the City of Umatilla, an Oregon Municipal Corporation (“City”) and Umatilla County, a political subdivision of the State of Oregon (“County”), for the transfer of a jurisdiction of roads from the County to the City that are located within the City limits.

Now, therefore, the City of Umatilla and Umatilla County agree as follows:

1. The County previously took action to transfer County Roads located within the City limits to the City.
2. The County will transfer an additional one-half mile portion of County Road No. 1225 (Powerline Road) from the South line of Section 29, Township 5 North, Range 28, E.W.M., to the East-West centerline of Section 32, Township 5 North, Range 28, E.W.M.
3. The County will transfer an additional portion of County Road No. 1281 (Lind Road) from the East-West centerline of Section 21, Township 4 North, Range 28, E.W.M., to its intersection with County Road No. 1268B (Bensel Road).
4. The County will transfer a portion of County Road No. 1272 (Power City Road) from its intersection with County Road No. 1281 (Lind Road) to Highway 395.
5. The County will transfer the following County Roads located within the City limits:
 - County Road No. 1287 (Brownell Boulevard);
 - County Road No. 1286 (Scaplehorn Road)
 - County Road No. 1275 (Umatilla River Road), from Highway 730 South to intersection with Jones Scott Road
6. The County will transfer any authority it has over the following Public Roads within the City limits:
 - Margaret Avenue
 - Marion Avenue
 - No Name Lane
 - Robnett Street
 - Cherry Street
 - Locust Street

3. The City will accept jurisdiction of the County Roads and Public Roads described and set out in the above paragraphs 2, 3, 4, 5 and 6.
4. To assist in any needed improvements to the roads, the County will pay to the City the sum of \$200,000 upon acceptance of the portion of the County Roads being transferred as provided by this agreement.
5. Transfer of jurisdiction will be full and absolute for all purposes of repair, construction, improvement, and the levying and collection of assessments.
6. Each party agrees to prepare and to execute any documents necessary to complete the transfer of jurisdiction.
