Business Items

1. STIF Plan Approval – Presented by Megan Davchevski, Umatilla County Planning Manager & Transit Coordinator. The Umatilla County Transportation Advisory Committee (UCTAC) met on December 4, 2024 and January 2, 2025 to evaluate STIF Plan applications. ODOT is recommending Qualified Entities to budget for 20% increase of STIF Payroll revenues. The recommended amounts include one payroll project that will be funded if the additional 20% revenues are available.

The UCTAC recommended approval of the proposed STIF plan projects and funding amounts. Funding requests were more than the allocation estimates, so some projects are recommended to receive less funding than requested.

Commissioner Shafer moved to approve the Umatilla County STIF Plan for 2025-2027, with a STIF Plan total (including carryover) of \$6,394,791.00 and authorize the Board Chair to sign the STIF Plan application. Seconded by Commissioner Timmons. Carried, 3-0.

Commissioner Dorran left the meeting at 10:07 recusing himself from Business Item #2.

- 2. City of Helix Request Presented by Cindy Wood, 46269 Hudemann Rd, Helix Advancement Partnership Network (HAPN); Judy Bracher, 80451 Kupers Rd, (HAPN); Jack Bascomb 415 Harrison Rd, (HAPN); Terry Case 210 Solar St, (HAPN). Funding for improvements to the Helix City Hall and Library building have been requested from the County. The funding is to make improvements to electrical work in bathroom, council room and museum, sheetrock all walls and ceiling, flooring, and doors for interior. The amount requested is \$40,000. The source for the funding was not identified. There may be HELP funds available. There are also incoming grants they will use to assist in preserving this building. An ADA accessible bathroom is being added. Commissioner Shafer moved to approve \$40,000 for the preservation of the Helix City Hall and Library building. Seconded by Commissioner Timmons. Carried, 2-0.
