Most districts, as defined in ORS 255.012, elect board members at the regular district election which is held in May of odd numbered years or at the Primary or General Election. As provided for in ORS 255.235(2)(a), the March and August deadlines included above are only applicable if the election is a district's first election to elect board member and are not included in the daily calendar.
