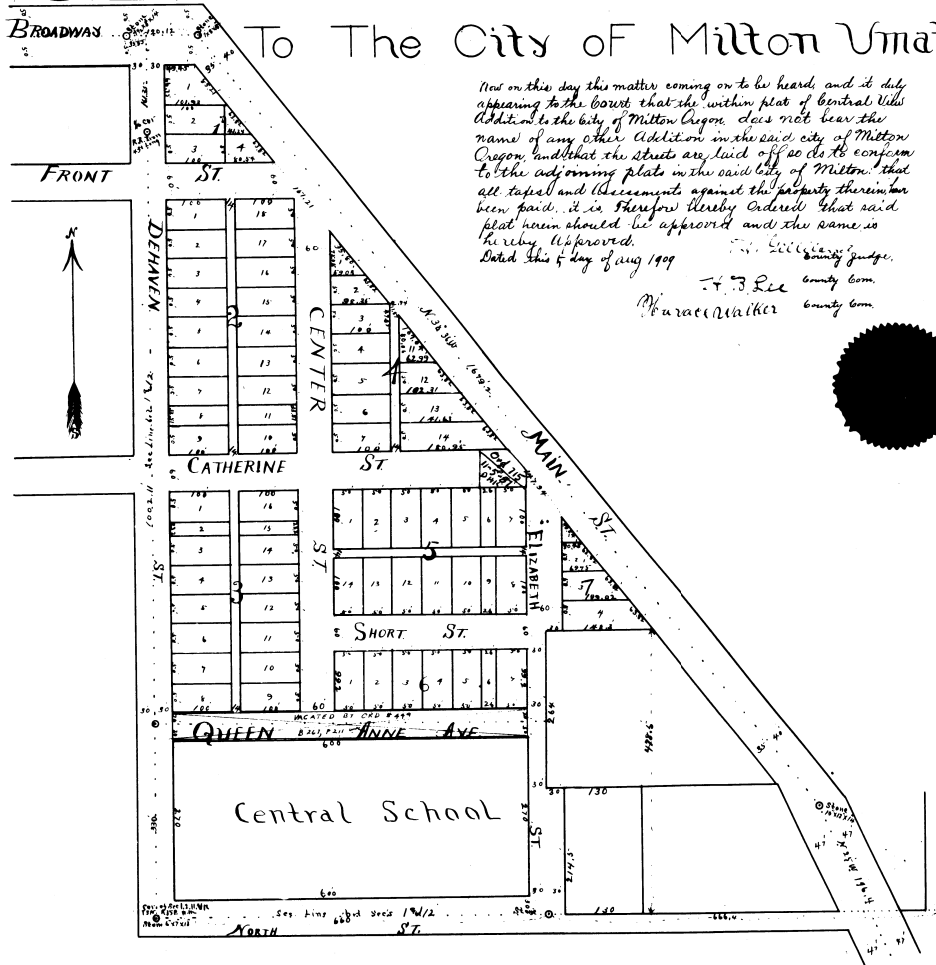


CENTRAL VIEW ADDITION

 I, L. A. Wilson the official City Surveyor of the City of Milton Umatilla County Oregon, being first duly sworn depose and say, I have surveyed the Addition to the City of Milton known as Central View Addition which begins at a point 250 feet north & west side of the corner of Sec 1, 2, NW 1/2 of T. 5 N. R. 3 E. M. 11. Thence North parallel with West Line of sec 1 113.46 ft. to a point in the produced South Line of Broadway St. of North Milton Thence east on said produced Line 48.85 feet to the westerly line of Main St. of said City of Milton Thence S 35 E 132.12 ft. along said westerly line of Main St. to a point 44.8 feet North of the South Line of said sec 1. Thence West 176.3 feet Thence south 146.5 ft. Thence West 630 feet to the point at beginning. This addition is 650 feet with monuments as shown on the plat. To wit: cor of sec 1, 2, NW 1/2 a stone 6 x 7 in. At N. cor. which is 132.12 ft North of said cor of sec 1, 2, NW 1/2 a Rail Road Iron 4 feet long. In Broadway 120 feet west of the intersection of said Broadway with Main a stone 7 1/2 x 4 1/2 at intersection of Main & Broadway, a stone 7 1/2 x 5 1/2 at the corner Main St. a 6 inch diameter of the 1/2 Cor 132.12 ft east of said cor of Sec 1, 2, NW 1/2 a stone 6 x 6 in. and that I have made a correct and accurate survey of the same.
