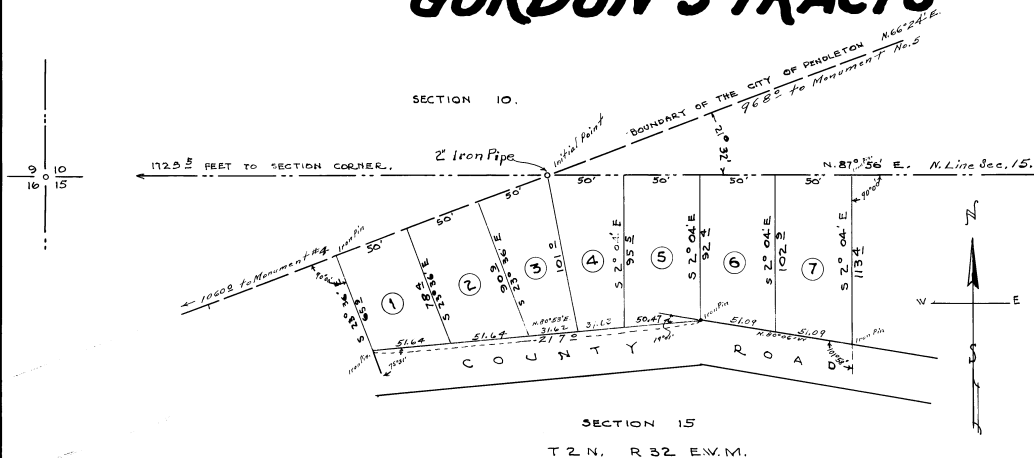


GORDON'S TRACTS

I, W.E.O. Criger, being duly sworn do testify and say that I have correctly surveyed and plotted the land as represented by the accompanying plat, the exterior boundaries, of which are described as follows: From a point 172.5 ft. East of the Northwest corner of sec. 15, T.2N, R.32 E, W.M. which is on the north line of said Sec. 15, and is the point of beginning; and where I set a two inch iron pipe 3 ft. long into the ground and drove the top 6" into the surface; thence easterly on said N. line of sec. 15, 200.2 ft. to a point, thence southerly and at right angle to the north line of sec. 15, 113.4 ft. to the north R/W line of the County Road, thence N.80°06' on said North Right way line 102.18 ft. to an iron pin, thence S.80°53' on the North Co. Rd. right of way line 217.5 ft. to an iron pin, thence N.23°36' W. 65.3 ft. to an iron pin on the south city limits boundary, thence N.66°24' E. on said City Limits boundary 150.2 ft. to the point of beginning. Iron pin was set at each boundary corner.
