I Elmo E Robnet, being duly sworn, do testify and say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are as follows:- beginning at a point on the line between townships 5 and 6, - 426.4 feet east and 2576.9 feet north of the 1/4 corner between sections 1 and 2, Twp. 5 R. 35 E.W.M. At that point I set a 2" iron pipe, 3ft long, the top being 6 inches below the surface of the ground as per Sec. 18-1304 of the Oregon code annotated. Running thence south parallel to the west line of Sec. 1 - 411.6 feet, thence east parallel to the township line - 5572 feet to the center line of Walla Walla Street, thence north along center line of Walla Walla Street - 411.6 ft to Twp. line, thence west along township line 539. ft. to point of beginning. Each corner of all lots is marked by an iron pin.

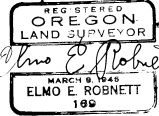
