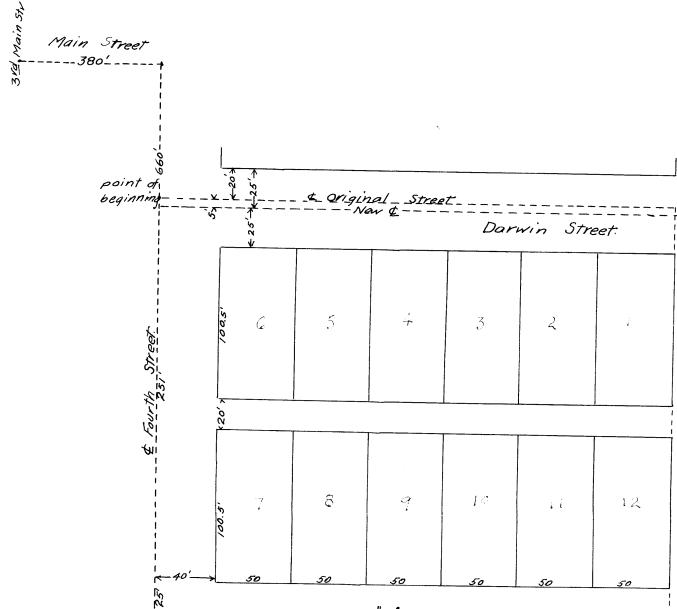
I, Elmo E. Robnett, being duly sworn do testify and say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are as follows:— starting at the monument at the intersection of Third and Main Streets in the City of Athena, Oregon, thence east on the center line of Main Street—380 feet to the monument at the intersection of Fourth and Main Streets; thence at right angles south along the center line of Fourth Street—660 feet to the point of beginning where I set a 2 inch galvanized iron pipe three feet long the top of which is six inches under the surface of the ground as per Sec. 85-1304 Oregon Code annotated; thence south along the center line of Fourth Street extended—276 feet to a 1 inch iron pipe; thence at right angles east—340 feet to a 1/4 inch iron pipe; thence at right angles north—276 feet; thence at right angles west—340 feet to point of beginning. The above described property was known as Lots 1 and 2 of Park Addition to the Town now City of Athena.
