Field Notes of Road Survey made May 26th & 27th 1879

Monday May 26th 1879

Met at the residence of C. Paylor. Monday May 26th 1879. Present Viewers St. State
and A. R. Price, who were duly qualified and after calling to my assistance & qualifying
the same according to law. W. M. Ewing & W. D. Scott to act as chain bearers and C. Paylor
to act as marker. proceeded to survey and mark out what is known as the Old Handed Road

- N 40 " 25 " Set 1/2 Sec. Corner bet: Sec 15 & 22 T. 4. N. R. 34. E.
- N 60 " Set Stake. Sawed, on hill in Mound Mounds A.
- W 80 " Set Stake round fir 59 4x4 - 3 1/2 in flat inside of field post Mounds Mounds 111 M
- W 5 " Set post 4x4 - 2 1/2 in Mound, outside of field Mounds A. Chopped Corner
- N. 21. W 80 " Set round fir post of the former divisions in Mound Mounds 11 M in flat near J. H. Williams house
- " 80 " Set post as req. by law. Mounds 9 & Mounds 11 M in flat near traveled road at Davis place.
- " 80 " Set post near Jas Mc Evans house Mounds 9 according to law & Mounds 11 M
- " 10 " Set the point of intersection with sec line bet Sec 28 & 29 T. 5. N. R. 34. E. Chopped Corner Set post for sawed 4x4 - 2 1/2 - 1 Mounds A
- N 77 " Along line bet: Sec 28 & 29 to Cor Sec: 20. 21. 28. & 29. T. 5. N. R. 34. E.
- N 80 " Set post according to law on each hill side Mounds 11 M
- N. 2 1/2 W 72 " along line bet Sec 20 & 21 to Cor Sec 16. 17. 20 & 21 T. 5. N. R. 34. E. Set 4x4 - 2 1/2 Sawed fir in Mound Mounds A. Chopped Corner
- E 80 " along line bet Sec: 16 & 21. Set post according to law Mounds VIII M. Mounded.
- E 72 " 50 " along line bet Sec. 16 & 21 to cor Secs. 15. 16. 21 & 22. T. 5. N. R. 34. E.
- E 80 " along line bet. Sec. 15 & 22. Set stake in Mound. according to law. Mounded Mounds IX M.
- E 80 " along line bet Sec 15 & 22. & Sec 14 & 23 T. 5. N. R. 34. E. Set post according to law near traveled road Mounds & Mounds X M
- E 58 " 38 " Set terminus post on each hill side in plowed ground Mound 10 & Mounds R.
