

ROAD NO
442.In the matter of Viewing, Surveying and Laying out County
Road No. 442.

Commencing at the terminus of Road Survey No. 385 for Umatilla County, Oregon, and running thence up the grade on Road Survey No 348 in said County, to its head, at intersection of the line running E 3^{rd} $1/2$ through the center of the South half of Sec 8 in T 3 N. R. 36 E; thence East along E 3^{rd} $1/2$ line about one-fourth mile; thence northeasterly on the route recommended by one of your Hon. Body May 20, 1894, to intersect the line running N 3^{rd} S. through E half of said Sec 8, as near as may be practicable; thence continuing up and on the north side of Wild Horse Creek on the most practicable route to intersect said road survey No. 348, at or near the line between Secs 8 and 9 in said township; thence E on N. side of Wild Horse Creek as near as practicable on survey 348 to the corner of Secs 10-11-14 2^{nd} 15 in said township; thence South on line bet. Secs 14 2^{nd} 15, as near as practicable, one-fourth mile and terminate. Then commencing at a point on the foregoing described route, at its intersection with a N 2^{nd} S line, passing through the center of the East half of said Sec 8, and running thence north on said N 2^{nd} S line, as near as practicable, to intersect the head of a road grade, at or near the $1/6$ Sec corner on the East half of line between Secs 5 2^{nd} 8 in said township; thence following said grade to its terminus at or near a point on the N 2^{nd} S line running through the center of the East half of Sec 5 in said township; thence North on said N 2^{nd} S line, and terminate at the initial point of said Road Survey No. 348. Said road to be forty feet wide.

Report of Viewers.

To the Hon. County Court of the State of Oregon, for Umatilla County:
We, the undersigned, the Viewers heretofore appointed to view out and locate Road No. 442 submit the following report: Pursuant to an order of the Honorable Court we met John W. Kimbrell Surveyor, at Athena, Umatilla County, on the 19th day of July, A. D. 1894, and were by him, each, duly sworn to faithfully and impartially discharge the duties of our appointments. We called to our aid Geary Kimbrell and Richard Todhunter, Chainmen, and Chas. A. Butler marker, who were by the Surveyor, each duly sworn. We viewed, surveyed and located said Road No. 442, as specified in our order, and find that the route, as specified, to be practicable, and would most respectfully recommend that the road be declared a public highway of Umatilla County, Oregon.
