KNOW ALL MEN BY THESE PRESENTS: That We, Seth M. Richardson and Abbie M. Richardson, being the owners of all the deeded land over which is desired to establish a County Road, in Umatilla County, State of Oregon, described as follows:

Commencing at a point known and designated as the North West Corner of Block 29, Reservation Addition to the City of Pendleton, and run thence Northerly, along the Easterly line of Tudor Willow Street, Pendleton, if the same was extended, a distance of thirty feet for point of commencement, run thence Northerly on said East line of Tudor Willow Street 323.70 feet to the South line of Court Street, Pendleton, if the same was extended Westerly; thence Easterly at right angles, and along the extended South line of said Court Street a distance of 390.4 feet; thence Northerly at right angles 60 feet to the North line of Court Street, Pendleton, if extended; thence Westerly at right angles and along the extended North line of said Court Street, a distance of 420.4 feet; thence Southerly at right angles 383.70 feet more or less to a point 30 feet North of Monument No. 1; thence Easterly at right angles to point of beginning, the same being an extension of West Court Street and North Tudor Willow Street, Pendleton, Oregon.
