REPORT OF BOARD OF COUNTY ROAD VIEWERS

IN THE MATTER OF VIEWING, SURVEYING AND LAYING OUT COUNTY ROAD NO. 638. TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY.

WE, THE UNDERSIGNED Board of County Road Viewers, heretofore instructed to view, survey, and locate Road No. 638, Submit the following report: Pursuant to an order of the Honorable County Court, we met at the office of County Surveyor in Pendleton, Ore on the 17 day of January 1908.

We called to our aid

J E Bennett Chainman
Wm Mills Marker

who were by the surveyor each duly sworn. We viewd, surveyed, and located said Road No 638 as specified in our order. We find said route practicable and would most respectfully recommend the same be established and declared a public highway of Umatilla County, Oregon. the cost of construction will be about \$75° including an under cattle crossing; the damages to be sustained by reason of the location of said road would be to Henry Mills nothing; the damage to be sustained by W. A. Mills estate would be nothing; the damage to be sustained by William Mills through Sec. 1 in Tp. 5 N. R. 31 EWM would be (\$275°) Two hundred and seventy five dollars.
