

## FIELD NOTES OF ROAD NO. 661.

Commencing at the corner of Secs. 27, 28, 33 and 34 in township 5 North Range 29, E. W. M..

Set post 4x4 inches 4 feet long S East of initial point, 40 feet distant marked R 661. Thence east between Sec. 27 & 34  $80^{\circ} 19'$  chs. Set post 4x4 inches 4 feet long NE  $40'$  Marked L.M. RT 622. Thence east between Secs. 25 & 35  $80^{\circ}$  chs. Set post 4x4 inches, 4 feet long, N E  $40'$  Marked 2. M. Thence east bet. Secs. 25 & 36  $80^{\circ}$  chs. Set post 4x4 inches 4 feet long  $30'$  North, Marked 3. m.

Thence east between Secs. 30 & 31, T. 5 N. R. 30 e.  $80^{\circ}$  chs. Set post 4x4 inches 4 feet long  $30'$  North. Marked 4. M.

Thence east bet. Secs. 29 & 32,  $80^{\circ}$  chs. Set post 4x4 inches 4 feet long  $30'$  North. Marked 5. M.

Thence east bet. Secs. 28 & 33  $14^{\circ}$  A. L.

Thence  $51^{\circ}$  E  $26.50$  chs.  $40.50$  A 2

Thence S  $25^{\circ} 45'$  E  $3.00$  chs.  $43.50$  R T. Set post 4x4 inches 4 feet long, 30 feet dist. to left Marked R. No. 661 at road from Holdman to Cold Springs Station. Corse at this Point N  $20^{\circ}$  W.

## REPORT OF BOARD OF COUNTY ROAD VIEWERS.

IN THE MATTER OF VIEWING, SURVEYING AND LAYING OUT COUNTY ROAD No. 661.

To the Honorable County Court of the State of Oregon, For Umatilla County.

We, the undersigned Board of County Road Viewers, heretofore instructed to view, survey, and locate Road No. 661, submit the following report:

Pursuant to an order of the Honorable County Court, we met at beginning of said road No. 661 in T. 5 N. R. 29 E. W. M., on the 15th day of October, 1908. We called to our aid

We find said route practicable and would most respectfully recommend the same be established and declared a public highway of Umatilla County, Oregon, except the first mile between secs. 27 and 34, which covers and includes the last mile of Road No. 622, a public highway. The cost of construction will be about \$60.00. The damage to be sustained by property owners through which said road is laid out will be nothing.
