REPORT OF COUNTY ROAD VIEWERS.

In the Matter of viewing, surveying and laying out county road to vacate. in T 4 & 5 N R 28 and 29 E W M

To the honorable county court of the State of Oregon for Umatilla county.

We, the undersigned, board of county road viewers, heretofore instructed to view, survey, and locate road to vacate submit the following report:

Pursuant to an order of the Honorable county court we met at the commencement of said road on the 25 day of January, 1910, We called to our aid, W J Stockman, chairman; Sam Williams, Chainman; J H Saling, flagman J W Kimbrell, marker, who were by the surveyor each duly sworn, we viewed surveyed and located said road to vacate as specified in our order. We find said route unnecessary for the use of the public as a highway, we therefore most respectfully recommend the same be abandoned and declared vacated.
