Beginning at a point in the County Road at the Northwest corner of the Southwest quarter of the Northeast quarter of section twenty-six in Township six North, of Range thirty-five E.W.M.: Running thence East one half mile to the Northeast corner of the Southeast quarter of the Northeast quarter of said section twenty-six: thence North forty rods: thence East one half mile along the center of the North half of the Northwest quarter of section twenty-five in said Township six North, of Range thirty-five E.W.M. to the County Road.
