the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in

the State of Oregon, to-wit: A strip of land Forty (40) feet wide, being Twenty (20) feet on

each side of the center line of said road, as surveyed over and across the South-

half of the Northwest Quarter of Section 26, T. 6 N. R. 36 E. W. M. Said center line being described as follows; Beginning at a point on the north and south center line of Section 26, T. 6 N. R. 36 E. W. M. approximately 709 feet north and 50 feet east of the center of said Section 26, thence N. 19 42' W., 700 feet more or less to a point in the center of County Road No. C 5, which point is approximately 1340 feet north and 300 feet west of the center of said Section 26, T. 6 N. R. 36 E. W. M.
