

# To the Honorable County Court of the State of Oregon, for Umatilla County

WE THE UNDERSIGNED, your petitioners, who are freeholders of said Umatilla County, Oregon, and who reside in the road district, or districts where said road is to be laid out, respectfully petition your honorable body to cause to be laid out, located, and established a County road in said County and State, commencing, running and terminating as follows, to-wit: Commencing At a point on County road, 20, 90 Chains North of the North-West corner of section 18, T. 5. N. R. 38. E. W. M. Thence following the present traveled County road in a south westerly direction to a point 1.36 chs West of the wagon bridge over small stream flowing through what is known as the Little Meadows, This point is also the point where the Pikes Peak Mountain road intersects the present traveled County road. And is the initial point of this petition. Thence following the old Pikes Peak Mountain road as near as possible, on the best and most practical route through sections 12 & 1. T. 5, N, R. 37, E. W. M. Sections 6, T, 5, N, R, 38, E. W. M. Sec- 31 T. 6 N, R, 38, E. W. M. And sections 36-25-23-15. T. 6. N. R. 37. E. W. M. To a point 4.74 chs west of the 38th mile post on the Oregon and Washington Boundary line. At which point intersect County Road No 305 of Walla Walla County. Washington.

Said Road to be Sixty feet wide.

And your petitions will ever pray.

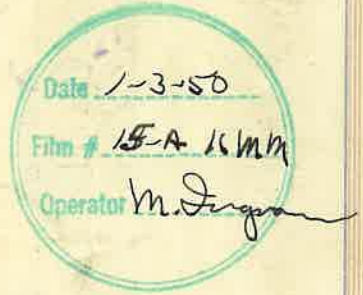
