RIGHT OF WAY DEED

IN THE MATTER OF OREGON ROAD, known as the Linton Mountain Highway,
KNOW ALL MEN BY THESE PRESENTS, That Herma C. Mallory and Maud Eichenberger, as executrixes of the estate of F. M. Kent, of the County of Walla Walla, in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One and No/100 Dollars paid to them, the receipt whereof is hereby acknowledged by them have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit:

A strip of land sixty feet wide for Highway purposes, the center line being described as follows:

Beginning at a point described as Engineers station 244/76, said station being described as lying 1161 feet west of the northeast corner of the SE 1/4 of Section 32, Twp. 5 North Range 36, E.W.M.; thence north 54 degrees 54 minutes West 53.4 feet; thence around a spiral curve to the right of the long cord of which bears North 47 degrees 29 minutes West a distance of 600 feet; thence North 40 degrees 04 minutes West a distance of 0.8 feet; thence around a spiral curve to the right the long cord of which bears North 34 degrees 29 minutes West a distance of 590 feet; thence north 29 degrees 14 minutes West a distance of 87.8 feet; thence around a spiral curve to the left the long cord of which bears North 30 degrees 50 minutes West a distance of 600 feet; thence North 32 degrees 25 minutes West a distance of 1260 feet to a point, said point being 1264 feet east of the southwest corner of the SE 1/4 of the SW 1/4 of Section 29, Twp. 5 No. Range 36, E. W. M., and containing 4.39 acres.
