In the Matter of the petition of Chas. Gerking for Electric Line along a Public Highway.

Now on this day this Matter coming on to be heard Upon the petition of Chas. Gerking,

IT IS HEREBY ORDERED that said Chas. Gerking, be, and he is hereby, permitted to construct and maintain an electric line for a distance of 170 rods along the County road in Umatilla County, Oregon, the same to connect with the Pacific Power & Light Co., said line to be constructed in such a way as not to interfere with the travel of the general public.

In the Matter of a Deed from Smith C. Stanton And Wife to Umatilla County, Oregon.

Now on this day there is presented to the Court a Deed signed by Smith C. Stanton and Jessie M. Stanton, his wife, conveying to Umatilla County, Oregon, a strip of land 20 feet wide being 10 feet on each side of a center line, described as follows:

Commencing at a point on the South side of a present County Road, South 59°<sup>30'</sup> West 900 feet from the center of Section 18, Township 5 North, Range 36 E.W.M.: thence South 50° 33' West 785 feet more or less, to the North bank of the Walla Walla River, the same to be used as a public highway of Umatilla County, and the Court being satisfied that said deed is a good and sufficient deed and properly executed,

IT IS HEREBY ORDERED that the same be, and is hereby, approved and considered as and for a County Road, and that the same be Recorded in the office of the County Recorder of Conveyances of Umatilla County, Oregon.

In the Matter of a Petition of J. M. Shell, et al, for a Justice of the Peace District.

Now on this day this matter coming to be ~~heard~~ considered upon the petition of J. M. Shell, et al, praying this Court to cause to be established a Justice and Constable District in Umatilla County, to include all of that part of Township 6, North, Range 38, E.W.M., lying within the State of Oregon; fractional sections 13, 24, 25, and 36, Township 6 North, Range 37, E. W. M; fractional sections 18, 19, 30 and 31, Township 6 North, Range 39m E. W. M., and after due consideration of the matter, the Court is of the opinion that the business to be transacted by such Justice District does not justify the establishing and maintaining a District in such locality,

IT IS, THEREFORE, HEREBY, ORDERED That said petition be, and the same is hereby denied.

In the Matter of County Road No. 794.

Now on this day this Matter comes on Regularly to be heard, and the matter not having been adjusted with the O W R & N Co.,

It is hereby ORDERED that further consideration of this matter be and the same is hereby continued until the February term of said Court.
