RIGHT OF WAY DEED

IN THE MATTER OF OREGON ROAD, known as the Oregon-Washington Highway.

KNOW ALL MEN BY THESE PRESENTS, That W.S.Price and Alice Price, his wife, J.H.Price and Clara B.Price, his wife, Nancy E.Lavender and D.F.Lavender, her husband, J.M.Price and Ada B.Price, his wife, C.M.Price and Clariassa Price, his wife, T.F.Price and Trenna Price, his wife, and J.C.Price and Mabel Price, his wife, being all the heirs of T.J.Price, deceased and Zerelda C.Price, deceased, in consideration of the benefits and other valuable considerations, and the sum of Sixteen Hundred Fifty (\$1650.00) Dollars, paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situated in Umatilla County, in the State of Oregon, to-wit:

All that part of the property of T.J.Price estate in the Northwest quarter of the South-east quarter of Section fifteen (15), Township Four (4), North Range Thirty-five (35), included within a strip of land 50 feet in width 25 feet on each side of the center line of Oregon-Washington Highway No.8, as surveyed over and across said property and as more particularly described as follows: Beginning at a point approximately 1350 feet North and 538.0 feet East of the quarter section corner between Sections Fifteen (15) and Twenty-two (22), Township Four (4), North Range Thirty-five (35), E.W.M., Umatilla County, State of Oregon; thence on a continuation of a 9° curve to the right whose central angle is 56°10' 331.8 feet; thence North 67°47' East 891.0 feet to a point approximately 1767.0 feet North and approximately 1320.0 feet East of the quarter section corner between Sections Fifteen (15) and Twenty-two (22), Township Four (4), North Range Thirty-five (35, E.W.M., said tract of land containing 1.04 acres of land more or less.
