In the matter of Oregon Road, known as the Oregon-Washington Highway

Know all men by these presents, That

J. N. York and Ida York his wife,

and his wife, of the County of Umatilla

in the State of Oregon. in consideration of the benefits and other valuable considerations, and the sum of

Two Hundred Seventy-five and no/100 Dollars,

paid to us, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the

County of Umatilla, State of Oregon, the following described parcel of land, situated

in Umatilla County, in the State of Oregon, to-wit: A strip of land 50 feet wide

being 25 feet on each side of the center line of said road, as surveyed over and across

N.E. 1/4 of N.W. 1/4 of Section 23, T.5 N.R.35 E.W.M.

All that part of the property of J. N. York in the N.E. 1/4 of the N.W. 1/4 of Section 23, T.5 N.R. 35 E.W.M. included within a strip of land 50 feet wide, being 25 feet on each side of the center line of the Oregon-Washington Highway No. 8, as surveyed over and across said property, and as more particularly described as follows:

Beginning at a point in the center of the present traveled County Road approximately 1105.0 feet South and approximately 1116.0 feet East of the corner of sections 14, 15, 22 and 23, T. 5 N. R. 35 E.W.M Umatilla County, State of Oregon; running thence N. 15° 10' W. 1146.1 feet to a point on the line between sections 14 and 23, approximately 819.0 feet East of the corner of Sections 14, 15, 22 and 23, T. 5 N.R 35 E.W.M.; said tract of land containing 1.32 acres of land more or less.

To have and to hold, the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
