the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across

the Southwest Quarter of the Southeast Quarter

of Section 23 Township 4 North Range 35 East W. M.

Beginning at Station 171 / 96 of the Weston Mountain Highway Survey

which Station is approximately 445 feet South and feet of the N.E. Corner

of the Southwest Quarter of the Southeast Quarter of Section 23, Twp. 4 N. R. 35 E.W.M. which is common to Sections Township Range East W. M.

Thence running in a Northwesterly direction approximately 809 feet to Station 179 / 05 of

the said survey, which Station is approximately 548 feet West and feet of

the aforesaid corner which is common to Sections Township

Range East W. M. Contains 1.12 acres more or less.
