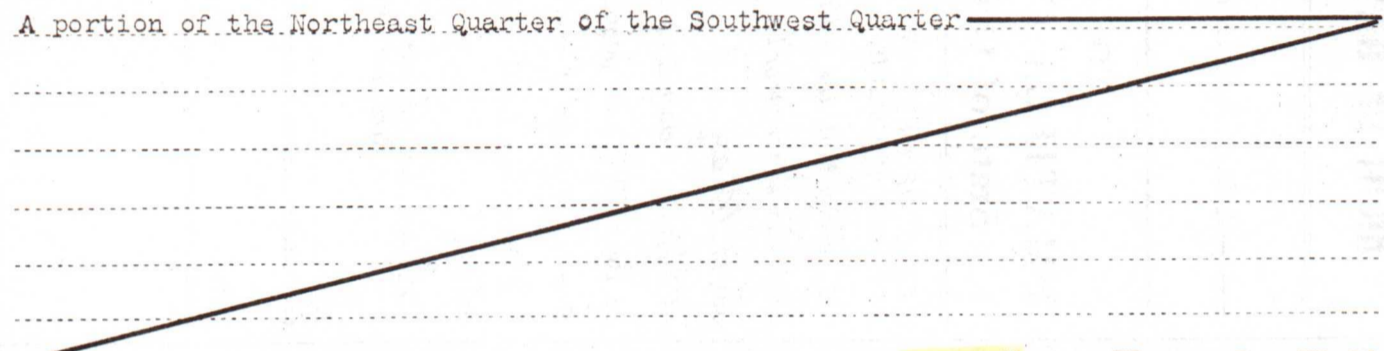

Thence running in a Southwesterly direction approximately 113 feet to Station 91 / 97 of

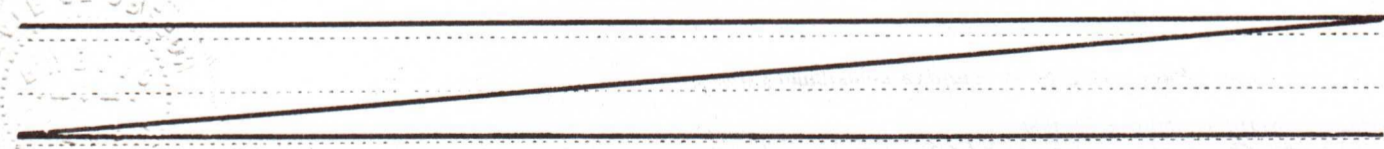

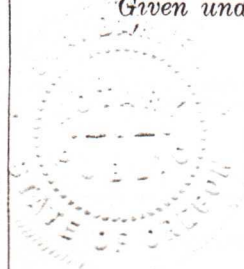
