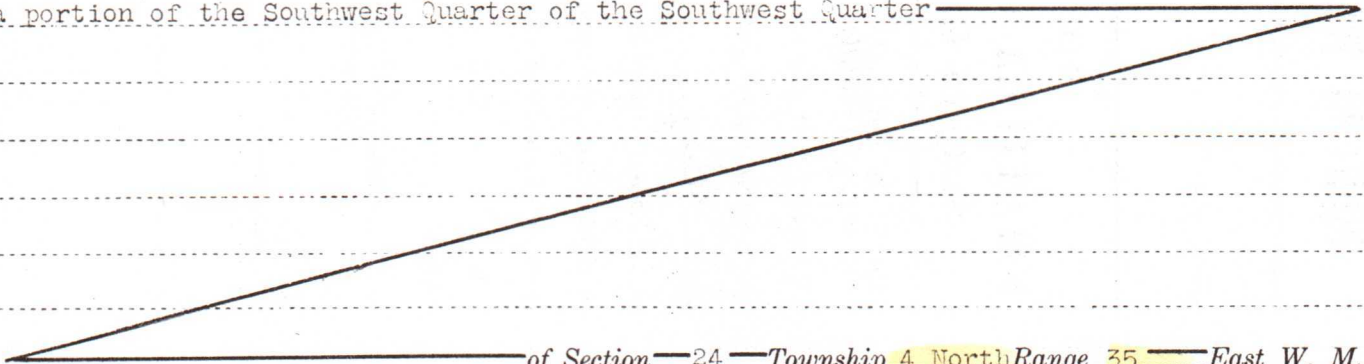
have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto

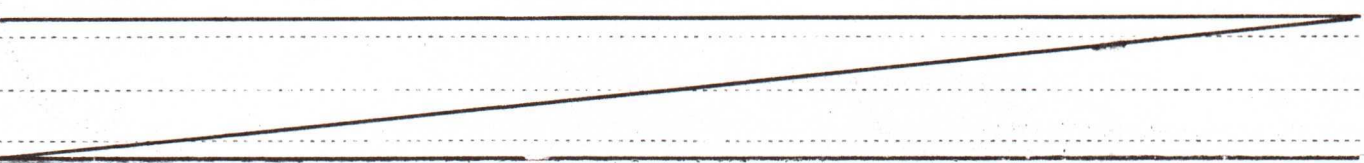
Thence running in a Southeasterly direction approximately 2013 feet to Station 127 & 30 of
