13 ed as follows, Beginning at the county road
14 now running North and South through
15 the middle of section (6) sixteen in Tp. 4 North,
16 Range (35) thirty five E. W. M. in Umatilla
17 County, Oregon at the S.W. corner of the
18 North East quarter of Section (6) sixteen
19 Tp. (4) four North, Range (35) thirty five E. W. M.
20 on said County road, Thence running in an
21 Easterly direction on the subdivision half
22 section line through the center of sections (5)
23 fifteen and (6) sixteen of said Tp. (4) four
24 North R. (35) thirty five E. W. M. to a point in
25 said County and State on said subdivision
26 (100) one hundred ft. West from the center of
27 the track of the Oregon Railway and Navigation
28 Company's spur which runs from the main

1 line of said Company's Spokane branch
 2 to the city of Weston in said County and State
 3 These running in a Southeasterly direction
 4 along the West side of said spur on a line
 5 parallel therewith and (100) one hundred feet
 6 distant there from to the corporate limits of
 7 the city of Weston aforesaid at a point on the
 8 boundary line of said corporate limits (100)
 9 one hundred feet distant in a Westerly
 10 direction from the center of said spur.

 12 will ever pray.
