paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide, being feet on

side of the center line of said road, as surveyed over and across and Margaret P. Adams, his wife a widow all that part of the property of Walter F. Adams and Susan F. Adams, included within a strip of land sixty (60) feet wide; being thirty feet on each side of the center line of said road as surveyed over and across Section 15 and the Northeast Quarter of Section 16.

of Section Township 3 N, Range 35 East W. M. Beginning at Station 276 + 10 of the Eagle Creek Highway Survey which Station is approximately 200 feet East and feet of the Section Corner which is common to Sections 9, 10, 15, & 16 Township 3 North Range 35 East W. M. Thence running in a Southeasterly direction approximately 9200 feet to Station 368 + 10 of the said survey, which Station is approximately 1320 feet West and feet of the Section corner which is common to Sections 14, 15, 22, & 23 Township 3 North Range 35 East W. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
