paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A strip of land sixty feet wide being thirty feet on each side of the center line of the Eagle Creek Market Road Survey in sections 21 and 22 Township 3 North, Range 35 East W. M. and as more particularly described as follows:

Beginning at a point known and designated as Station 358 on the Eagle Creek Market Road Survey which point is 278 feet West of the Quarter Section corner common to Sections 21 and 22, T. 3 N., R. 35 E.W.M., thence S. 30° 10' W. a distance of 171.3 feet, thence on a 358.1 foot radius curve left a distance of 278.5 feet, thence S. 14° 24' E. a distance of 855.3 feet, thence on a 573.0 foot radius curve left a distance of 420.2 feet, thence S. 56° 25' E. a distance of 55.0 feet to a point known and designated as station 375/80.3, which point is on the Section line 1636 feet South of the above described Quarter corner. Also beginning at a point known and designated as station 387/52 which point is 2040 feet South of the above described Quarter corner, running thence N. 78 59' W. a distance of 878.7 feet, thence on a 573.0 foot radius curve left a distance of 242.3 feet, thence S. 76° 37' W. a distance of 677.3 feet, thence on a 1422.5 foot radius curve left a distance of 358.8 feet, thence S. 62° 16' W. a distance of 1554.0 feet to a point known and designated as station 424/63.1, which point is 505.4 feet East of the Southwest corner of the Southeast Quarter of the Southwest Quarter of Section 21 Township 3 North, Range 35 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever. The grantee herein, as part of the consideration aforesaid, agrees to build a good and substantial three wire fence with cedar posts a rod apart on each side of the above described strip of land or right of way
