has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet wide on each side of the center line of the Eagle Creek Market Road as surveyed over and across the Southeast Quarter of the Northeast Quarter of Section 21, Township 3 North, Range 35 East, W.M. Said center line being more particularly described as follows; Begining at a point on the south boundary of the said Southeast Quarter of the Northeast Quarter of Section 21 which point is 278 feet west of the Quarter Section corner common to Sections 21 and 22, T. 3 N. R. 35 E. W.M., thence N. 30 10' E., 22.9 feet, thence on a 240.5 feet radius curve left, 209.4 feet, thence N. 20 06' W. 61.5 feet, thence on a 573.7 feet rdius curve left, 461.0 feet, thence N. 26 00' E., 313.7 feet, thence on a 206.7 feet radius curve left, 249.3 feet, thence N. 43 48' W., 7.2 feet, thence on a 359.3 feet radius curve right 90 feet to a point on the north boundary of the Southeast Quarter of the Northeast Quarter of Section 21, which point is 155 feet west of the Northeast Quarter of the Southeast Quarter of the Northeast Quarter of Section 21, All in Township 3 North, Range 35 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
