have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in

the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line of said road as surveyed over and across the Southeast Quarter of Section 19, Township 4 North, Range 35 East, W.M. and more particularly described as follows: Begining at a point known and designated as Station 21 / 07.3, which point is 612 feet North and 1330 feet West of the Southeast corner of Said Section 19, thence South 00° 59' West, 00.0 feet, thence on a curve to the left of Radius 573.0 feet, 400.7 feet, thence South 39° 05' East, 297.2 feet to a point known and designated as Station 28 / 05.2, which point is 1013 feet West of the Southeast corner of Said Section 19. All in Township 4 North, Range 35 East, W.M. Contains 0.90 acres more or less.
