have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land *SIXTY (60)* feet wide, being *THIRTY (30)* feet on *each* side of the center line of said road, as surveyed over and across
