Umatilla County, State of Oregon, to-wit: A parcel of ground for highway purpose..... located in the SW $\frac{1}{4}$ of section 5, Township 3 North, Range 36 E.W.M., the said parcel being more particularly described as beginning at a point..... 365.2 feet more or less south of the northwest corner of the SW $\frac{1}{4}$ of section 5, Township 3 North, Range 36 E.W.M., thence running North 49 degrees 16 minutes East a distance of 549 feet more or less to the east and west center line through said section 5; thence west and along the east and west center line through said section 5 a distance of 416.1 feet to the northwest corner of the SW $\frac{1}{4}$ of said section 5; thence south and along the section line between sections 5 and 6 a distance of 365.2 feet to the place of beginning all located in section 5, Township 3 North, Range, 36, E.W.M. and containing 1.74 acres more or less.
