Now on this day comes the report of viewers, Jerry Barnhart, August Zeuske and J.W. Kimbrell, heretofore appointed at the March Term of this Court to view out and report upon the location of the above road as a County Road, for final hearing, the same having been read at a previous day of this term to-wit: The May term, 1904, and the said viewers having reported favorably and recommended the establishing of the same as a County Road and the field notes and plat of survey being duly on file and certified to by the Surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said Road, It is Therefore Ordered by the Court that the report of said viewers be accepted, and that the said road be established as a County Road in accordance with the report of said viewers, and that the field notes and plat of survey thereof be duly recorded as by law required and that the Supervisor through whose District said Road runs be directed to open the same for public use as a County Road.

In the matter of County Road No. 558. Commencing running and terminating as follows: Commencing at the present County Road where it Crosses the North and South Center line in Section 16, Township 6 North of Range 34, E W M, running thence South two and one half Miles (2-1/2) miles more or less to the South Line of section 28 in said township and Range; Thence East one mile to connect with the present County Road on the South line of section 27 in said Township and Range Road to be 40 feet wide. ROAD NO. 558.

Now on this day Comes the report of viewers, Frank Dickenson Dan Kinney and J.W. Kimbrell heretofore appointed at the March Term of this Court to view out and report upon the location of the above road as a County Road, for final hearing the same having been read at a previous day of this term, to-wit: the May term, and the said viewers having reported favorably and recommended the establishing of the same as a County Road and the field notes and plat of survey being duly on file and certified to by the Surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said road, It is Ordered, by the Court that the report of said viewers be accepted and that the said road be established as a County Road in accordance with the report of said viewers, and that the filed notes and plat of survey thereof be duly recorded as by law required, and that the Supervisor through whose district said Road runs be directed to open the same for use as a County Road.

Commencing running and terminating as follows: Commencing at a point about 200 yards east of the South-west corner of the South East quarter of Section 35, Township 6 North, Range 31, East of the Willamette Meridian, and running thence in a Northeasterly Direction through Sections 35, 36 & 25, of Township 6 North, Range 31 East of Willamette Meridian, and through sections 30, 19 & 18 of Township 6 North, Range 32, East of Willamette Meridian, ending at a point about 80 rods, North of the Northeast corner of Section 19 Township 6 North, Range 32, East of Willamette Meridian said Road to be forty feet wide.
