KNOW ALL MEN BY THESE PRESENTS, That UMATILLA COUNTY, a political subdivision of the State of Oregon, does hereby convey unto the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, the following described property, to wit:

A parcel of land lying in the SW $\frac{1}{4}$ of Section 10, Township 4 North, Range 34 East, W.M., Umatilla County, Oregon, and being that property described in that certain deed to State of Oregon, by and through its State Highway Commission, recorded in Book 160, Page 341 of Umatilla County Records of Deeds; the said parcel being described as follows:

Beginning at a point in the Easterly right of way line of the County Road, said point being 1792.2 feet North and 1282.3 feet East of the Southwest corner of said Section 10; thence North 23 $^{\circ}$ 57' West along said right of way line, a distance of 200 feet; thence North 58 $^{\circ}$ 48' East, a distance of 303.3 feet; thence North 79 $^{\circ}$ 07' East, a distance of 300 feet; thence South 10 $^{\circ}$ 53' East, a distance of 300 feet; thence South 79 $^{\circ}$ 07' West, a distance of 539.3 feet to the point of beginning, containing 3.57 acres.

No monetary consideration was received by Umatilla County for this deed.
