each side of the center line of said road, as surveyed over and across the Northeast Quarter of Section 4, T. 3 N. R. 34 E. W.M. Said center line being more particularly described as follows; Beginning at the intersection of the center lines of Main and Commercial Streets in the City of Adams, Oregon, thence North along the center line of said Main Street, 710 feet to the North boundary line of Holdman's Addition to the said City of Adams, thence continuing North approximately 450 feet to a point on the North line of the South Half of the Northeast Quarter of Section 4, T. 3 N. R. 34 E. W. M. which point is approximately 1330 feet south and 760 feet west of the Northeast corner of Section 4, Township 3 North, Range 34 East, W.M.
