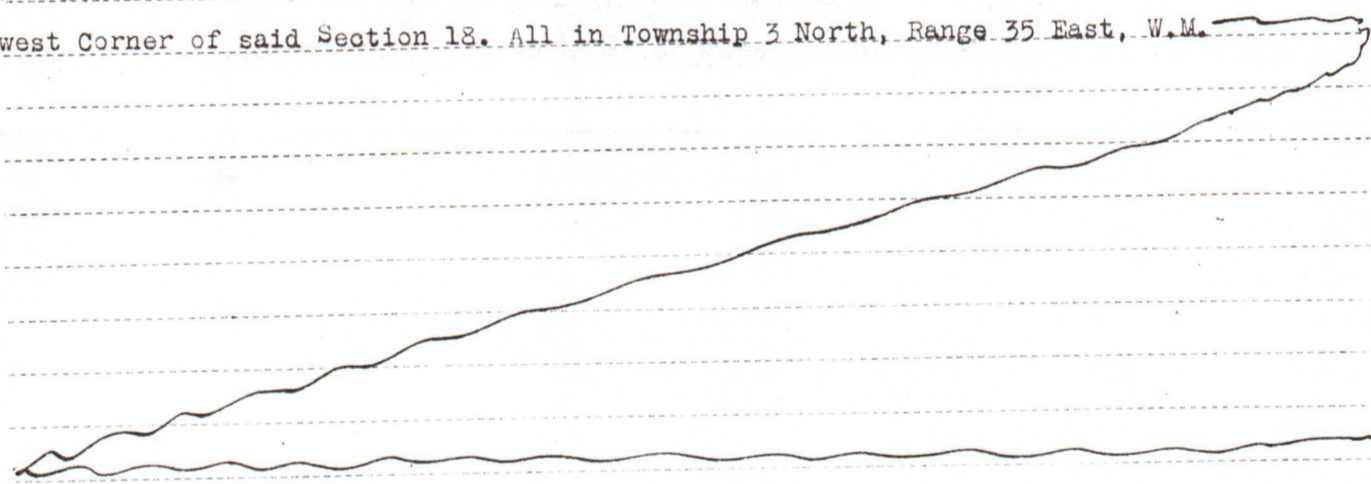
Know all men by these presents, That Frank S. Curl and Nancy J. Curl, his wife

paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line of said road as surveyed over and across the Southwest Quarter of Section 18, Township 3 North, Range 35 East, W.M. and more particularly described as follows; Beginning at a point on the Section Line, 1375 feet west of the Southwest Corner of Section 18, thence North 44 17' West, a distance of 0.0 feet, thence on a curve to the right of radius 1432.5 feet, a distance of 219.6 feet, thence North 35 30' West, a distance of 2018.0 feet to a point on the Range Line, 1933 feet North of the Southwest Corner of said Section 18. All in Township 3 North, Range 35 East, W.M.



To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
