paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: All that part of the property of Lola Rogers Barnett and Harold Barnett, her husband, in the Northeast Quarter of Section 19, Township 3 North, Range 35 East, W.M. included within a strip of land 60 feet wide, being 30 feet wide on each side of the center line of said road as surveyed over and across said property and as more particularly described as follows; Begining at a point on the Section Line 985 feet South of the section corner common to Sections 17, 18, 19 and 20, thence North 85 54' West, 0.0 feet, thence on a curve to the right of radius, 5730 feet, a distance of 1061.7 feet, thence North 75 17' West, a distance of 1645.3 feet to a point on the Quarter Section line, 458 feet South of the Quarter Section corner common to Sections 18 and 19. All in Township 3 North, Range 35 East, W.M.
