have granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: All that part of the property of Carl Plucker in the Southwest Quarter of the Southwest Quarter of Section 21, Township 3 North, Range 35 East, W.M. included within a strip of land 60 feet wide, being 30 feet wide on each side of the center line of the road as surveyed over and across said property and more particularly described as follows; Begining at a point on the east boundary of said property approximately 30 feet north of the the Southeast corner of the Said Southwest Quarter of the Southwest Quarter of Section 21, thence North 37 55' West, approximately 1710 feet to a point on the North boundary line of said property, said point being approximately 215 feet east of the Northwest corner of the said Southwest Quarter of the Southwest Quarter of Section 21.
