has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across the Northwest Quarter of Section 33, Township 4 North, Range 34 East, W.M, Said Center Line being more particularly described as follows: Beginning at a point known and designated as Station 58 / 55, which point is 105 feet west of the center of said Section 33, thence North 40 16' West, 284.5 feet, thence on a 1432.69 feet radius curve to the right, 319.6 feet, thence North 27 29' West, 2440.9 feet to a point known as Station 89 / 00, which point is 975 feet West of the corner common to Sections 28, 29, 32 and 33, Township 4 North, Range 34 East, W.M. Contains 4.19 acres more or less.
