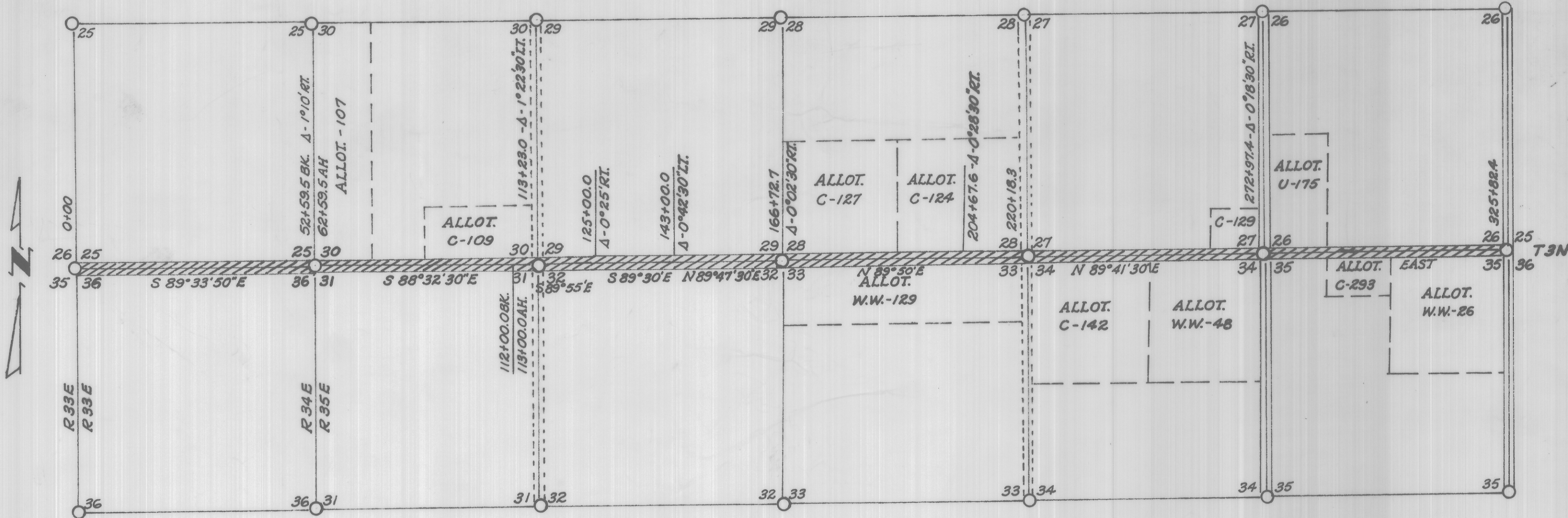

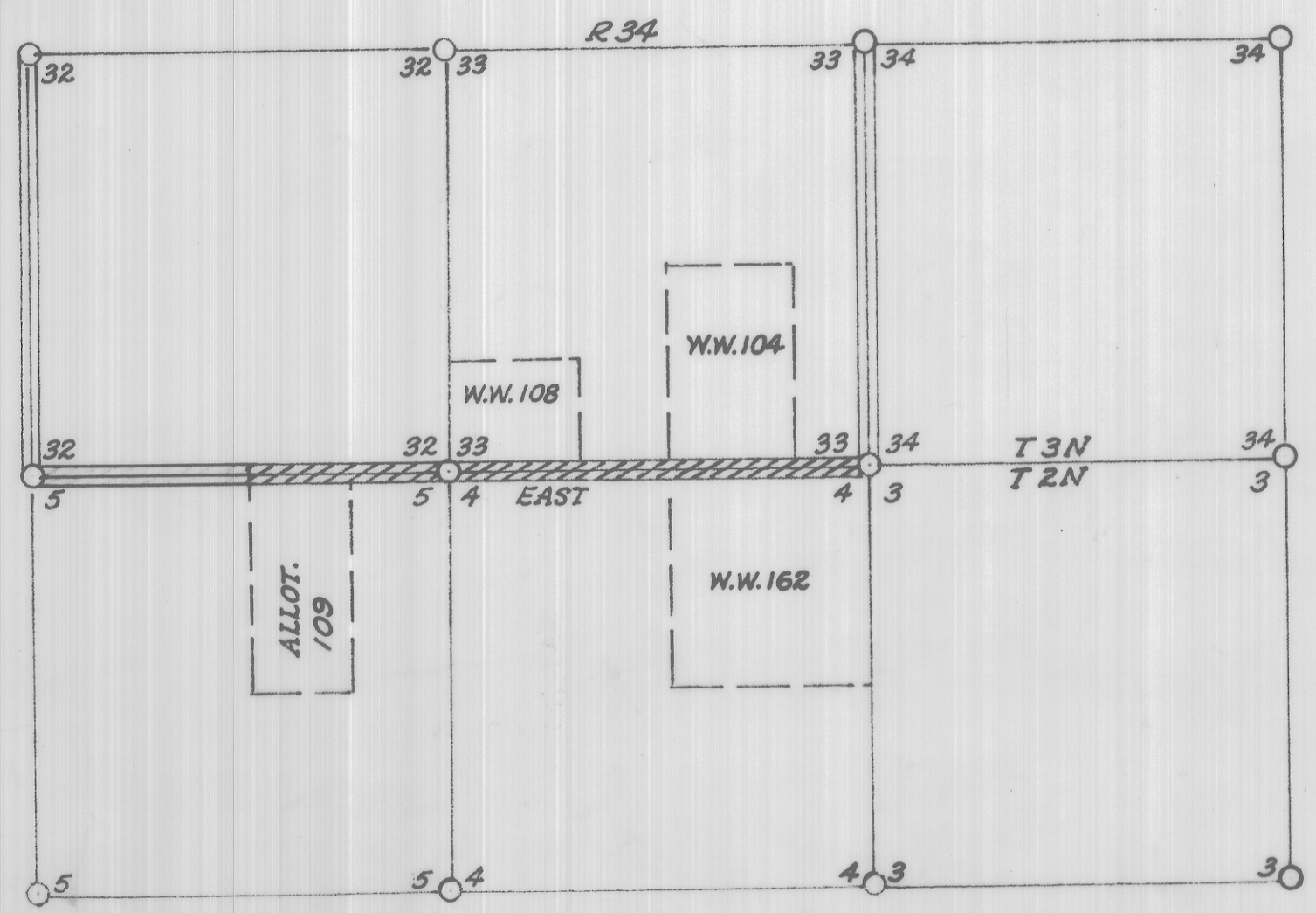

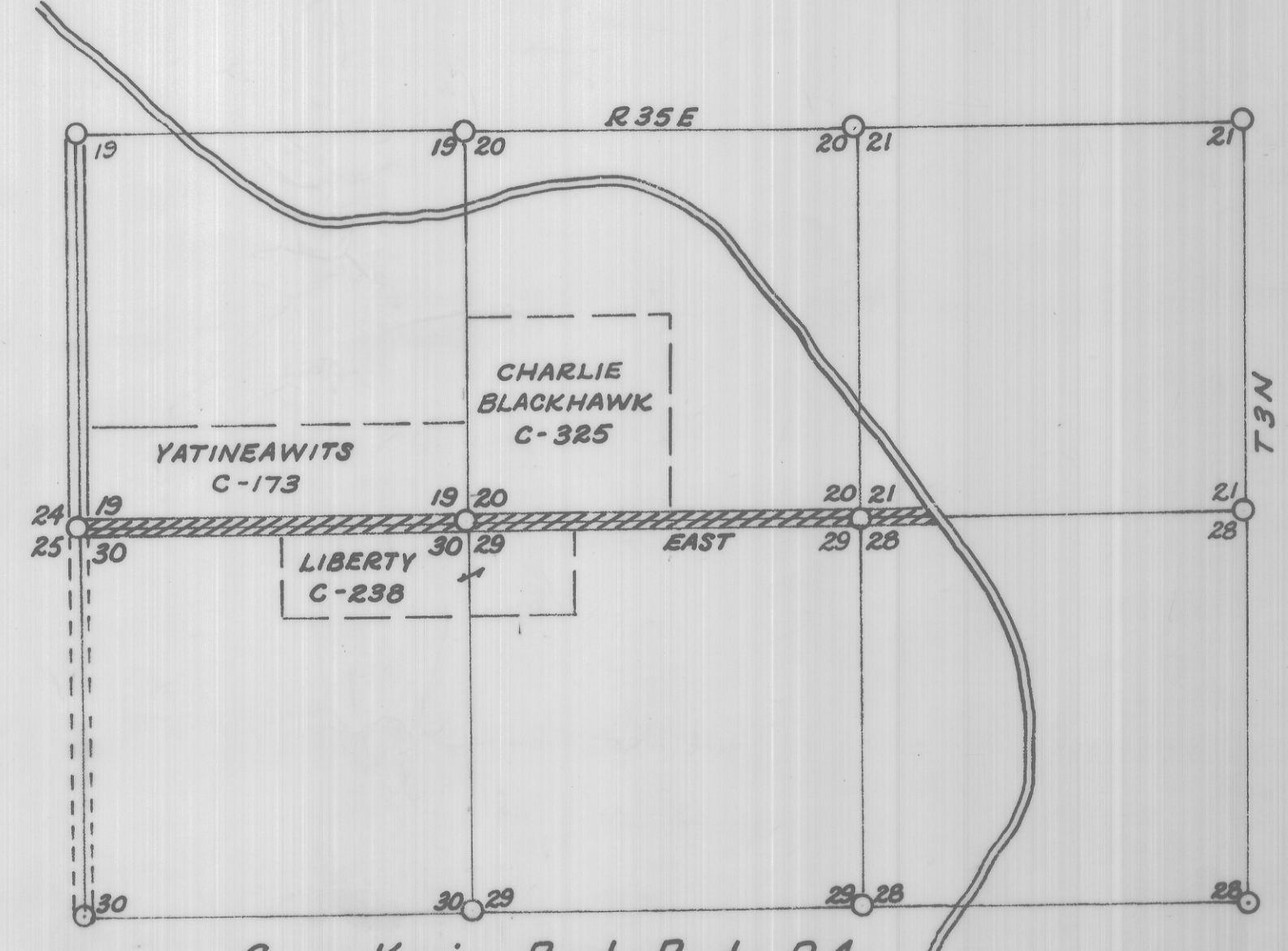


Hall - Toyslap Road - Route 30
