has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point 1412 feet west and 1685 feet south of the north East corner of the North West 1/4 of section 1, Twp 4 North, Range 33, E.W.M.; thence along a tangent with an approximate bearing of North 18° 44' East for a distance of 119.5 feet; thence around a 3° C.R. for a distance of 1261 feet; thence along a tangent with an approximate bearing of North 56° 34' East for a distance of 757 feet; thence around an 8° C.R. for a distance of 11.3 feet to a point in property line which point is 120 feet south and 22 feet west more or less of the North East corner of the North West 1/4 of Section 1, Twp 4 North, Range 33, E.W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
