Know all men by these presents, That George W. Piper and Lorene Piper, his wife,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One and No/100-- Dollar

paid them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point which point is 1040 feet west and 20 feet north more or less of the quarter corner common to sections 5 and 6, Twp 4 North, Range 34, E.W.M.; thence along a tangent with an approximate bearing of north 33° 38' west for a distance of 303.4 feet; thence around a 10° curve right for a distance of 165.2 feet; thence along a tangent with an approximate bearing of north 17° 8' west for a distance of 1663.7 feet; thence around a 12° curve right for a distance of 90.4 feet to a point in the property fence which point is 820 feet east more or less of the north east corner of the NW 1/4 of section 6, Twp 4 North, Range 34, E.W.M.

Also a strip of land 30 feet wide running along the north side of section 6, Twp. 4 North, Range 34, E.W.M., said strip beginning at a point 790 feet east more or less from the north west corner of the NE 1/4 of section 6, Twp. 4 North, Range 34, E.W.M. and terminating at the north west corner of the NE 1/4 of section 6, Twp. 4 North, Range 34, E.W.M.; also all land included by a 174.6 foot radius curve connecting the south line of the thirty foot strip and the west right of way line of the Sand Hollow road.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

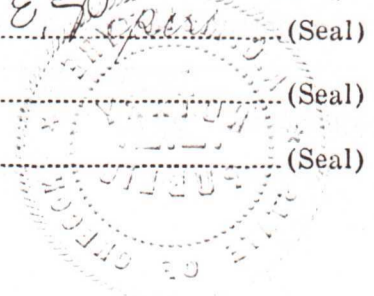
