has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey

unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point which point is 900 feet south and 30 feet west more or less from the center of section 8, Township 4 North, Range 34, E.W.M.; thence along a tangent with an approximate bearing of North 26° West for a distance of 921.9 feet; thence around a 1° curve left a distance of 325 feet; thence along a tangent with an approximate bearing of North 29° 40' West a distance of 2877.1 feet to a point in the property line, said point being 650 feet east and 20 feet south more or less from the section corner common to sections 5, 6, 7 and 8, Township 4 North, Range 34, E.W.M. Also beginning at a point which point is 1215 feet west and 1555 feet north more or less of the quarter corner common to sections 16 and 17, Township 4 North, Range 34, E.W.M. said point being station 2407.06 on the survey; thence along a tangent with an approximate bearing of north 27° 57' west for a distance of 760.2 feet; thence around a 4° curve right for a distance of 196.2 feet; thence along a tangent with an approximate bearing of north 20° .6' west for a distance of 446 feet to a point in the property line which point is 820 feet east and 20 feet south more or less of the quarter corner common to sections 8 and 17, Township 4 North, Range 34, E.W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
