Notice is hereby given that a petition will be presented to the County Court of the State of Oregon, for Umatilla County, by the undersigned, who are residents and householders of said County and State and reside in the vicinity of the hereinafter described route for a County road, at the *January* term of county court of said County Court, to-wit: on the *8<sup>th</sup>* day of *January* 1890. praying said Court to lay out, locate and establish a County road in said County and State, commencing, running and terminating as follows, to-wit:

Commencing *at the south east corner of section (16) sixteen T P (4) four north of range (33) thirty three east of the willamett meridian running north on the <sup>section line</sup> line of said section (16) sixteen and section (15) fifteen one mile more or less to the north east corner stake of said section (16) sixteen thence east on the section line of said section (15) fifteen and section (10) ten one mile more or less to the north east corner stake of said section (15) fifteen there to terminate at county road and your petitioners will Ever Pray*

Said road to be *40* feet wide.
