TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed in Special Road District No. 51, known as South Cold Springs Road

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of January 19 29, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed road

shall commence, run and terminate as follows, to-wit:  
Beginning at a point 102.3 feet South and 380 feet East of the South-East corner of Section 33, Twp. 4 N. of Rg. 32 E. W.M., also beginning at a point 102.3 feet North and 380 feet East of the above-described corner, thence in a Northwesterly direction down South Cold Springs Canyon along the most feasible route to a point 1729 feet South of the Quarter Section corner common to Sections 10 and 15, Twp. 4 N. of Rg. 31 E. W. M.

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet on each side of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: that it is part a portion of the highway designated by the formation of the above entitled Special Road District.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular March term for the year 1929, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by Walter Fanson, Deputy Road Master as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
